WE HAVE ISSUED A STATE TAX LIEN FOR YOUR DELINQUENT CALIFORNIA PERSONAL INCOME TAXES. THE LIEN ATTACHES TO ALL REAL PROPERTY YOU OWN OR ACQUIRE IN SAN BERNARDINO COUNTY.

A lien is a public record and may seriously damage your credit until it is released. Failure to pay the balance due immediately may result in additional collection actions, including taking part of your wages, contacting third parties, and taking other actions allowed by law, without further notice.

The balance due shown below summarizes the tax liabilities included in this lien and the lien recording fees (listed under COLLECT FEES). Additional penalties and interest accrue at the rate set by law from the notice date to the date we receive payment. However, no additional interest will accrue if we receive full payment within 15 days from the date of this notice.

Upon satisfaction of the tax liability (including any penalties and accrued interest) represented by the lien, the Franchise Tax Board will record a certificate of release in the county recorder where the state tax lien is recorded. A lien release will be mailed no later than 40 days after the liability is satisfied. If payment is made by check, the 40-day period does not commence until the check has been paid by the financial institution upon which it was drawn.
